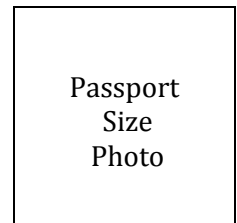

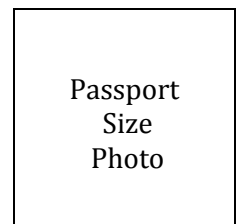

Instruction for Members

- Membership Fees for every member of general body is Rs.10/- (Rupees Ten only) per month is has been fixed by registrar of society and to pay minimum amount is contribution and to take active part in the activity is compulsory.
- Membership will terminate automatically if a member is found guilty in any criminal or police case.
- If a member is found inactive the membership will the ternate with the consent of 2/3 members.
- It is responsibility of the member to give resignation to the head office by registered post three months in advanced and Email in case he can not remain active and wait for the acceptance of the resignation letters by the general body.
- To keep written document of every work done, Photographs, Press cutting etc in a proper file and deposited in the had office every year.
- To remain in contact by latter and Email with the head office.
- If any telephonic conference is organized and any resolution is passed / and consent or suggestion is given, it should be confirmed by registered post.
- It will be the duties of every member to attend the meeting are conferencing.
- Member is not supposed to take part in any political activity.

Difference between Company and Society:-

According to Indian Company Act.1956 a shear holder or a partner is a partner of the company, as per Society Act. 1980 the members don't have any rights on the property of society.

In case of dissolution of society the property of society can not be divided amongst the members nor any one can have occupation of the society.

Members are authorized under special restrictions for proper management and security of the society. the restriction may be depicted in the By-Lows of the society.

So company and society are two different entities.

Ordinary member: Any parson who pays Rs.10/- par month or Rs.120/- par year as contribution will be remain the member for the period he has paid the contribution if any member who dos not pay the contribution for Six month without satisfactory reason his membership will be terminated. Such member can be made member again by fresh application and paying the dues of the contribution.

Acquisition of Membership: - Any parson desirous of becoming member will have to apply in the proscribed from.

Such application will be presented to the Governing Body.

Who has the right to accept are reject giving the reason for the rejection.

- सदस्य राजनेतिक गतिविधियों में भाग नहीं ले सकता है ।
- पत्र एवं ई-मैल द्वारा प्रधान कार्यालय से नियमित जुड़े रहें ।

समिति (Society) तथा कम्पनी (Company) में अन्तर

भारतीय कम्पनी अधिनियम, 1956 के अधीन पंजीयत कम्पनी के अंशभागियो या हिस्सेदारों का कम्पनी में उनका स्वयं का हिस्सा होता है। सोसायटी रजिस्ट्रीकरण अधिनियम 1860 के अधिन पंजीयत समिति के सदस्यों का समिति की संपत्ती में कोई हिस्सा नहीं होता । समिति भंग होने पर ना तो संस्था की संपत्ती सदस्यों में बाटी जा सकती है और न कोई सदस्य समिति की संपत्ती में अपना आधिपत्य जमा सकता है । पंजीयत समिति के सदस्यों को केवल समिति की सुव्यवस्था व सुरक्षा का अधिकार विशेष प्रतिबंधों के साथ प्राप्त हैं। ऐसे विशेष प्रतिबंधों का उल्लेख समिति विनियमों में हो सकता है। अतः कम्पनी तथा इस अधिनियम के अधीन पंजीयत समिति दो अलग-अलग प्रकार के वैधानिक अस्तित्व हैं ।

साधारण सदस्य :- जो व्यक्ति 10/- रु. प्रतिमाह या 120/- रु. प्रतिवर्ष एक मुश्त समिति को चंदे के रूप में देगा वह साधारण सदस्य होगा । साधारण सदस्य केवल उसी अवधि तक सदस्य रहेगा जिसके लिए उसने चंदा दिया है जो साधारण सदस्य बिना संतोषजनक कारणों के छः माह तक का देय चंदा नहीं देगा उसकी सदस्यता समाप्त हो जावेगी। ऐसे सदस्य द्वारा सदस्यता के लिये नया आवेदन-पत्र देने तथा बकाया चंदे की राशि देने पर पुनः सदस्य बनाया जा सकेगा ।

सदस्यता की प्राप्ति :- प्रत्येक व्यक्ति को जो कि समिति का सदस्य बनने का इच्छुक हो समिति द्वारा निर्धारित फार्म पर लिखित रूप से आवेदन करना होगा। ऐसा आवेदन-पत्र प्रबंधकारिणी समिति को प्रस्तुत होगा जिसे कि उस आवेदन-पत्र को स्वीकार करने या कारण बताते उसे अमान्य करने का अधिकार होगा ।
